GENERAL TERMS AND CONDITIONS

1. Registration:

Registration has to be made, if possible, at least 4 weeks before the course starts (this is valid for individual courses, courses in small groups, standard courses). In case there are less than 4 weeks until the beginning of the course, we kindly ask to contact the School to make sure that the course is still available.

The registration form has to be completely filled in and signed (please check the course you would like to attend by writing down the correct starting and end date) and to be sent to the school by e-mail. On registration it is necessary to make a deposit of 30 % of the total course fees by bank transfer or by credit card. It is advisable to send a copy of the bank transfer. In agreement with the school's students' office payment can also be made by credit card or cash at the school.

The balance of the course fees has to be paid in full to the school at least 2 weeks before the course start date or, in agreement with the School, latest by the second day of the course.

Language holiday courses have special payment conditions established on registration with the group.

Students applying for a study visa have to pay the <u>full amount</u> on registration. In case the visa application is denied, the student will receive a refund of the amount paid less 150 Euro administration fees.

2. Payment

Bank transfers have to be made to the following bank account:

Bank transfer charges, or other charges incurred for the payment of the course fees, are strictly for the account of the student!

In agreement with the School, the deposit and the balance of the course fee can be paid in cash or by credit cash in the office of the School

3. Cancellation:

a) Cancellation must be notified to L'Italiano Porticando by e-mail. In case of cancellation up to 4 weeks before the course's starting date, the school will refund the deposit. The registration fee (60,00 Euro) included in the deposit is non-refundable.

If cancellation is made up to two weeks before the start date, 50% of the course fees will be refunded, less the non-refundable registration fee. For cancellations made less than two weeks before the start date or for courses started and not completed no refund will be made.

For group courses, the school reserves the right to change prices, times and total number of hours, if there are not enough registrations for a course. The participants will be timely informed.

b) Cancellation of private lessons (on site and online):

Single **private lessons** have to be cancelled by the students at least **24 hours** before the fixed date. Otherwise, these hours will be considered as taken and lost for the student.

The package of hours bought must be used within 12 months from the starting date. After this deadline the hours remaining will be considered lost.

4. Insurance:

Neither L'Italiano Porticando, its staff or tutors are responsible for any injury, or loss of things or damages to things during the courses. Students are advised to take out all appropriate travel, medical and cancellation insurances in their country of origin before departure. The school is solely responsible for injuries and damages to things caused by the school.

The law of Italy governs any contract between L'Italiano Porticando Srl and the student. Court of jurisdiction is Turin.

5. Accommodation:

If requested by the student, the school can provide information about accommodation in Turin and arrange it for the student. After having been provided with the contact of the accommodation (host-family, B&B, Hotel ...), the student will contact them to communicate time of arrival and departure and all details regarding payment. The School is not responsible for any kind of problems coming up with the accommodation and the student is asked to respect the rules and conditions of the accommodation booked.

6. Obligations of the Student:

The students is obliged to: - obtain all required legal documents to enter and stay in Italy;

- purchase an insurance policy in case of long term stay with student visa
- purchase a health insurance policy (EU citizens need form E111)
- notify the School of any possible absence (mandatory for students with student visa)
- follow the rules established in the School
- respect the rules and conditions established in the places of accommodation

7. Courses:

Private lessons, Courses in small groups, Standard courses, Online courses, Combined Courses and Cultural courses include the language lessons and/or the lessons about the cultural topic chosen, the registration fees, an entry test, the school's free afternoon activities (for onsite courses), course book and certificate of attendance. The lessons are of 55 minutes each.

For German BILDUNGSURLAUB the total number of lessons per week will correspond to those requested by the various Laender.

Special topic courses include:

- language tuition (15 or 30 lessons of 55 minutes in the morning) and extra-curricular activities in the afternoon (museum tickets, bus tickets and meals are not included, unless not explicitly included in the programme description)
- registration fees
- cultural activities and excursions, accommodation, guided visits to museums, seminars as described in the details of the course.

8. National holidays:

There are no lessons on weekends and on national holidays (1/1, Easter Monday, 25/4, 1/5, 2/6, 15/8, 1/11, 08/12, 24/12, 25/12, 26/12, 31/12). The hours missed will be spread over the remaining days of the week in which there is a holiday.

Information on the processing of personal data as per EU REGULATION 679/2016

L'ITALIANO PORTICANDO S.r.I. processes personal data in accordance with the principles of correctness, lawfulness, transparency and integrity and confidentiality laid down in the Regulation; in particular, the data controller collects data on the following legal bases

- 1. Consent (where foreseen, because it concerns health data);
- 2. fulfilment of contractual and legal obligations to which the data controller is subject;
- 3. overriding legitimate interest of the owner or of third parties to whom the data are communicated.

L'ITALIANO PORTICANDO S.r.I. processes personal data for the following purposes

- to comply with legal requirements; in order to comply with obligations required by law, by a regulation, or EU legislation, or with the instructions of authorities or supervisory bodies;
- to consulting this domain;
